Firstly you should understand what a rhetorical essay is, and what the contextual understanding of this type of essay is. This essay category is one of the technical types of essay. In this essay, you are required to come up with an essay that is justified with the appeals such as ethos, pathos, and logos. Ethos refers to the appeals of ethics, i.e. ethical dilemmas and ethical approaches. The essence of pathos is deep-rooted in the ideology of emotions and the emotional appeals that can help or insist people make some sort of decisions. Then, logos are all about logic and the logical insights that can help to come up with a concrete response or to add to the underlying meaning.



When you are talking about the essence of the essay structure, you need to be careful of the formatting. Actually, the minimum number of paragraphs that you are required to add in a rhetorical analysis essay is "five". I should [write my essay](#) with a total of five paragraphs, where the first paragraph will be of introduction. The next paragraphs should be three in number and these paragraphs will explain the context of the topic. Your essay should end with the conclusion paragraph. When you will write your essay in the

form of five paragraphs, you will be writing by following the standard essay format. The introduction paragraph should end with a thesis statement in which you will explain your aim. The three body paragraphs should be a detailed insight into the major idea that is explained. If you are asserting something you should explain the ideas to claim the point. If you are arguing something the following paragraphs should be a set of counterarguments that can help to know the ideas that will add to the understanding of the central ideas.

The conclusion paragraph will be a short summary of all the points that you have mentioned in the above paragraphs. The summary should not have something new rather it would be a single sentence approach to the complete essay. If [essay writer](#) are to write an essay that is extensive i.e. 5-8 pages, then you can add more than three paragraphs in the body paragraphs. However, the requirement of the introduction and conclusion section will remain the same.
